In pursuance of Section 8 read with Section 4 of the Delimitation Act, 2002 (33 of 2002), and having regard to all other relevant Constitutional and statutory provisions in this regard, the Delimitation Commission hereby determines: -

- a) the total number of seats to be allocated to the NCT of Delhi in the House of the People as Seven (7);
- b) of the total number of Seven (7); seats so allocated to the NCT of Delhi in the House of the People, the number of seats to be reserved for the Scheduled Castes and Scheduled Tribes as One (1) and Zero (0) respectively;
- c) the total number of seats to be assigned to the Legislative Assembly of the NCT of Delhi, as Seventy (70); and
- d) of the total number of Seventy (70) seats so assigned to the Legislative Assembly of the NCT of Delhi, the number of seats to be reserved for the Scheduled Castes and Scheduled Tribes as Twelve (12) and Zero (0) respectively.

(ii) Whereas the name of a constituency as shown in Table A or Table B is distinguished by the brackets and letters **(SC)**, the seat in that constituency is reserved for the Scheduled Castes.
