Subject: - Special revision of electoral roll w.r.t 1.1.2012- final publication -regarding

Sir,


I am directed to state that the final publication of rolls is to be made on 2nd January, 2012 in your state. The Commission has announced the schedule for General Election to Legislative Assembly of your state on 24th December, 2011. The Commission has directed as below-

- i. CEOs shall ensure that adequate number of copies of electoral roll are printed and kept ready at least one day before the final publication and shall send a confirmation message to ECI.
- ii. The DEO shall convene a meeting of all recognized political parties on the day of final publication i.e. 2nd January, 2010 in the forenoon. A hardcopy of complete set of roll, along with soft copy in CD, shall be given to them and proper acknowledgement obtained and kept in record for perusal of the Commission's observer later
- iii. In the aforesaid meeting, the DEO should explain to the representatives of political parties that even after final publication it is open for citizens to file applications ,under the

provisions of continuous updation, for inclusion/deletion/correction of entries in the finally published roll. Statutory position with respect to the disposal of applications should be clearly explained in this meeting. It should be explained that according to the law the electoral roll is frozen at 3 PM of the last day of filing of the nominations. However, because rules provide that a clear seven days notice period is necessary before disposal of application by the concerned EROs, only those applications can be disposed of by the EROs which are filed at least eight days before the last date of filing of nomination paper from that AC. Political parties may take a careful note of it.

- iv. It shall further be ensured that finally published roll is hosted at CEO's website at 10.00 AM of 2nd January, 2012 and a certificate to this effect is faxed to the Commission latest by 11.00 AM
- v. One printed copy of supplement of the roll shall be given to each BLO at least one day before the final publication with a direction that they shall, without fail, at 10 AM on 2nd January, 2012 display it at the polling station at least for 7 days time for public inspection. In the same way, the roll shall be published at the office of concerned EROs/AEROs as well as DEO and such other public places as deemed fit at 10AM of 2nd January, 2012. One copy should be made available at each VRC centre also.

Please ensure compliance of the aforesaid instructions. Also give a copy of this to State unit of all political parties of your state.
