Sub: - Allotment of reserved symbols under Para 10 of the Election Symbols (Reservation & Allotment) Order, 1968. – **Samajwadi Party** - regarding.

Sir

I am directed to refer to the subject cited and to state that “**Samajwadi Party**” a recognized State party in the State of Uttar Pradesh having reserved symbol ‘**Bicycle**’ in that State has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968, for allotment of the said symbol ‘**Bicycle**’ to the candidate being set up by the said party at the current general election from **2-Bharmour(ST), 3- Chamba, 5-Bhattiyat, 6-Nurpur, 8-Fatehpur, 10-Dehra, 11- Jaswan-Pragpur, 12-Jawalamukhi, 13-Jaisinghpur(SC), 15-Nagrota, 16-Kangra, 17-Shahpur, 18-Dharamshala, 19- Palampur, 22-Manali, 31-Jogindernagar, 35-Sarkaghat, 38-Hamirpur, 41- Chintpurni (SC), 42-Gagret, 44-Una, 45- Kutlehar, 51-Nalagarh, 54-Kasauli(SC), 57-Sri Renukaji(SC), 59-Shillai, 62-Kasumpti and 64-Shimla Rural Assembly Constituencies of Himachal Pradesh.**

The Commission has decided to extend the concession sought by the party under paragraph 10 of the Election Symbols (Reservation and

Allotment) Order, 1968. Accordingly, the candidate set up by "Samajwadi Party" at the current general election from 2-Bharmour(ST), 3- Chamba, 5-Bhattiyat, 6-Nurpur, 8-Fatehpur, 10-Dehra, 11- Jaswan-Pragpur, 12-Jawalamukhi, 13-Jaisinghpur(SC), 15-Nagrota, 16-Kangra, 17-Shahpur, 18-Dharamshala, 19- Palampur, 22-Manali, 31-Jogindernagar, 35-Sarkaghat, 38-Hamirpur, 41- Chintpurni (SC), 42- Gagret, 44-Una, 45-Kutlehar, 51-Nalagarh, 54-Kasauli(SC), 57-Sri Renukaji(SC), 59-Shillai, 62-Kasumpti and 64-Shimla Rural Assembly Constituencies of Himachal Pradesh shall be allotted the symbol 'Bicycle'. The Returning Officer may be informed that the candidates set up by "Samajwadi Party" in the aforesaid Consituencies are eligible for the allotment of the symbol 'Bicycle' under paragraph 10 of the Symbols Order, 1968 subject to strict fulfillment of each of the provisions of paragraph 13 thereof.
