General Election to the Legislative Assembly of NCT of Delhi, 2013- Concession to candidates set up by registered unrecognized political parties- allotment of common symbol under Para 10B of the Election Symbols (Reservation and Allotment) Order, 1968- Regarding.

Sir,

I am directed to state that the application of the following 1(one) registered unrecognized political party for concession for allotment of a common symbol to its candidates to be set up at the forthcoming general election to Legislative Assembly of NCT of Delhi under the provisions of para 10B of the Election Symbols (Reservation and Allotment) Order, 1968, has been accepted by the Commission. Accordingly, the Commission has decided to extend the concession sought under Para 10B to the candidates of the said one party for the forthcoming General Election to Legislative Assembly of NCT of Delhi, 2013, in the constituencies mentioned under:-

Sl. No.	Name of the Party	No. of assembly constituencies	Common Symbol allotted.
1.	<b>Peace Party</b>	In all the 70 assembly constituencies of the NCT of Delhi.	<b><u>Ceiling Fan</u></b>

2. The Returning Officers of the above mentioned Assembly Constituencies be directed to allot the common symbol mentioned above to the candidates set up by the aforesaid one registered un-recognised political party, subject to fulfillment of the provisions of Para 13 of the Election Symbols (Reservation and Allotment) Order, 1968 relating to setting up of candidates by the party. It may also be noted that said common symbol allotted to the candidates of this party is not allotted by oversight to any other candidate



in these constituencies. However, the said symbol shall be available for allotment as free symbol to other candidates in all other constituencies, and in the constituencies where the aforesaid parties do not actually set up their candidates.

3. In the event of the above said party failing to meet the requirement of the minimum number of candidates, as prescribed in Para 10B of the said Symbols Order, 1968, i.e., 10% of total number of Assembly Constituencies, then the said common symbol shall not be available to its candidates.
